What is PCI SSC and PCI DSS?

The Payment Card Industry Security Standards Council (PCI SSC) was formed by the five major card brands to standardize the compliance requirements for all merchants accepting payment cards.

PCI Data Security Standard (PCI DSS) is a set of guidelines put in place to ensure that merchants follow best practices in order to protect consumers through steps that reduce credit card fraud and security breaches.







PCI Data Security Standard (DSS) – The Digital Dozen

Build and Maintain a Secure Network and Systems

- 1. Install and maintain a firewall configuration to protect cardholder data
- 2. Do not user vendor-supplied defaults for system passwords and other security parameters

Protect Cardholder Data

- 3. Protect stored cardholder data.
- 4. Encrypt transmission of cardholder data across open, public networks.

Maintain a Vulnerability Management Program

- 5. Protect all systems against malware and regulatory update anti-virus software or programs.
- 6. Develop and maintain secure systems and applications





PCI Data Security Standard (DSS) The Digital Dozen

Implement Strong Access Control Measures

- 7. Restrict access to cardholder data by business need-to-know status.
- 8. Identify and authenticate access to system components.
- 9. Restrict physical access to cardholder data.

Regulatory Monitor and Test Networks

- 10. Track and monitor all access to network resources and cardholder data.
- 11. Regularly test security systems and processes.

Maintain an Information Security Policy

12. Maintain a policy that addresses information security for all personnel.





Data Breach Security Program

The Data Breach Program is designed to help your merchants meet the significant expenses resulting from a suspected or actual breach of credit card data – regardless of the merchant's PCI compliance status.

For a low monthly fee, the program covers:

- Up to \$100,000 per MID
- No deductible or retention within one year following the discovery of a data security event
- Prompt assistance and automatic filing with all relevant entities





Common Questions

I'm only a small business. Why do I need to be compliant?

85% of security breaches take place in a Level 4 business with fewer than 20,000 card transactions annually. That's why the card brands mandated that all businesses, regardless of size, must become compliant.

My business is low risk; I'm not concerned about compliance.

Even the lowest risk business is vulnerable to a security breach. And expenses from a breach can be financially devastating, even as high as \$500,000. Compliance greatly reduces this risk.

This seems like a high fee; I may choose another processor.

The PCI Program fee is not unique to Global Payments; nearly all other processors are charging a fee to their customers. Our fee is in fact, lower than many of our competitors and compliance will keep those fees minimal.

Will compliance guarantee that I won't have breach expenses?

While it certainly reduces the risk, there are no guarantees against a security breach. However our Data Breach Security Program offers coverage that can cover some of the expenses if a breach occurs.
